
INFORMATION GUIDE FOR INTERNATIONAL STUDENTS 2017/2018

1. University of Ljubljana

University of Ljubljana among top 3% in the world

The University of Ljubljana is the oldest university in Slovenia, proud of its strong tradition. Over 40,000 students upgrade and develop their knowledge and skills at the country's largest educational institution, famous for top-quality achievements in social science, natural science, humanities and engineering degree programmes, as well as for artistic achievements by the three academies. Furthermore, the University has been most successful in research, therefore the central and largest research institution in Slovenia, with 30% of all registered researchers. It promotes interdisciplinary and multidisciplinary studies and exchanges its achievements in science and art with other universities and scientific research institutions. Particular concern of the University of Ljubljana is also the transfer of knowledge to the economy, which is why it cooperates closely with Slovenian and foreign companies. Its partners are multinational corporations and top Slovenian companies.

2. Degree programmes

2.1. BACHELOR AND SINGLE-CYCLE MASTER DEGREE PROGRAMMES

Bachelor and Single-cycle master degree programmes

- Bachelor academic degree programmes 180 or 240 ECTS credit points and of 3 or 4 years duration;
- Bachelor professional degree programmes 180 ECTS credit points and of 3 years duration;
- Single-cycle master degree programmes 300 or 360 ECTS credit points and of 5 or 6 years duration.

University Members (faculties and academies) offer 158 bachelor and single-cycle master degree programmes in the academic year 2017/2018. Calls for enrolment are published every year in February. Programmes cover contents from all academic fields, i.e. humanities, social sciences, arts, engineering and natural sciences. Furthermore, members provide single-cycle master degree programmes for EU regulated professions, such as medicine, dental medicine, veterinary medicine, pharmacy and architecture. Bachelor degree programmes last 3 or 4 years, while the single-cycle master degree programmes last 5 or 6 years.

2.2. MASTER DEGREE PROGRAMMES

The University of Ljubljana accredited over 200 master degree programmes, more than 10 are joint, i.e. accredited and provided jointly by the University of Ljubljana and universities from abroad. Not all accredited master degree programmes are offered for enrolment every year. University Members (faculties and academies) offer 195 master degree programmes in the academic year 2017/2018. The programme provision is published in the annual Call for enrolment, published on **www.uni-lj.si/study/master**, expected in February for the next academic year.

The Call includes offered degree programmes, the relevant programme data regarding study duration, entry requirements, access criteria and number of available places. Candidates are provided with explanations of entry requirements and costs of study at the University Member (academy or faculty) contacts, together with information about enrolment application, application deadlines, required evidence of fulfilment of entry requirements, and any tests of special talents.

Application deadlines

Please check for the deadline in the Call for enrollment for specific degree programme. In case there is no specific date, the deadline for submitting applications is September 10, 2017.

2.3. DOCTORAL DEGREE PROGRAMMES

Doctoral degree programmes are organised and implemented by University Members (academies, faculties). They are mostly interdisciplinary and cover different fields of science. They differ in the degree of interdisciplinarity and method of coordination. They last 3 years and consist of 180 ECTS credit points. The Call for enrolment in doctoral degree programmes is published at the University website usually at the **beginning of February** for the next academic year.

The Call includes offered degree programmes, data on study duration, enrolment requirements, the number of open positions, mode of study and place of study.

Candidates receive detailed explanations of enrolment requirements, application possibilities under transfer criteria and costs of study at the University Members (academies, faculties) delivering the programme, along with information about enrolment application, application deadline, required evidence of the fulfilment of enrolment requirements, and any required additional obligations to be met prior to enrolment in a degree programme.

Candidates can also receive detailed information on enrolment requirements, costs of study and other information on interdisciplinary doctoral degree programmes in Biomedicine, Statistics, and Environmental Protection at the University Office for Doctoral Study at the University of Ljubljana Rectorate. Candidates for doctoral study are selected at the relevant University Member (academy, faculty) or the University Rectorate for interdisciplinary doctoral degree programmes Biomedicine, Statistics, and Environmental Protection and enrolled at the relevant University Member (academy, faculty) no later than 30 September for the next academic year following a selection procedure. Candidates for doctoral study at the University of Ljubljana may apply, regardless of whether they have already graduated or not at the time of application. Graduation is not a requirement for application, but it is a requirement for enrolment. Candidates must choose a potential mentor before enrolling and at least generally agree on the contents of the doctoral dissertation and participation in research work. Help in choosing the right mentor can be provided by the coordinator of the respective doctoral degree programme.

Application deadlines

The application deadlines are different for every degree programme and are specified in the Call for enrolment for each doctoral degree programme separately (from June 2017 to September 2017). We especially call attention to the fact that the candidates must carry out any prescribed additional obligations (in accordance with the conditions for enrolment that are published next to the Call for enrolment for the doctoral degree programme) before enrolling into the degree programme.

3. Study possibilites

3.1. BACHELOR AND MASTER FULL-TIME STUDY

Most bachelor and master degree programmes are implemented as full-time study provision allowing students to attend lectures, tutorials and seminars in full provision.

3.2. BACHELOR AND MASTER PART-TIME STUDY

Part-time study is not possible in all bachelor and master degree programmes (see the relevant Call for enrolment). Part-time study is provided in accordance with specially defined lecture and tutorial schedule, as decided by the relevant University Member (academy or faculty).

In the Republic of Slovenia, academic year starts on 1 October and ends on 30 September. Every year, the study calendar specifies the duration of organised study activities, examination periods, school holidays, public holidays and of the university week. The academic calendar may differ from one University member to another. Please check the website of a particular University member (academy/faculty) for details.

A candidate successfully completes an exam if he/she receives a grade between adequate (6) and excellent (10).

Performance at exams in doctoral studies can also be evaluated with the following grades:

- failed;
- passed;
- passed with distinction.

The specific methods of assessing performance in exams in doctoral studies are set out in the respective doctoral degree programmes.

ECTS credits:

- 1 full academic year = 60 credits;
- 1 semester = 30 credits.

6. Application for enrolment and recognition of foreign education

6.1. APPLICATION FOR ENROLMENT

Candidates submit the application for enrolment and recognition of foreign education through eVŠ web portal portal.evs.gov.si/prijava/?locale=en



- **1. using a qualified digital certificate application is considered if** submitted through eVŠ before the application deadline as defined by the relevant Call for enrolment. The required supplements must be sent by registered mail (the supplements must indicate the reference to the number of the application for enrolment);
- 2. without using a qualified digital certificate (with a username and password) application is considered if submitted through eVŠ before the deadline as defined in the relevant Call for enrolment, and if printed, signed and sent by registered mail to the address in the top left corner of the printed application form before the deadline as defined in the relevant Call for enrolment. The required supplements must be sent by registered mail (the supplements must indicate the reference to the number of the application for enrolment).

- available places for bachelor and master full-time degree programme provision for international students (international students D, E, F), as a rule, cannot exceed 20% of the available places for Slovenian citizens and EU citizens;
- available places for bachelor and master part-time degree programme provision for international students (D, E, F), as a rule, cannot exceed 50% of the available places for Slovenian citizens and EU citizens;
- international students may apply for all available places in doctoral degree programmes.

6.2. RECOGNITION OF FOREIGN SECONDARY EDUCATION

Candidates with completed foreign education undergo a procedure of recognition of foreign qualifications upon applying for studies. The procedure starts with the candidate's application for study in the Republic of Slovenia, which is submitted in electronic form on the:

portal.evs.gov.si/prijava/?locale=en portal. The procedure is run by authorised persons at the University to which the candidate applied as their first choice.

6.3. RECOGNITION OF FOREIGN EDUCATION FOR ENROLMENT IN MASTER AND DOCTORAL STUDIES AND FOR TRANSFER

Enrolment in master and doctoral degree programme

Candidates with foreign degree qualifications undergo a procedure for the recognition of foreign higher education qualifications upon applying for studies. The procedure starts with the candidate's application for study in the Republic of Slovenia, which is submitted in electronic form on the **portal.evs.gov.si/prijava/?locale=en** portal. The procedure is run by the authorised person at the University Member (academy or faculty).

6.4. APPLICATION AND ADMISSION PROCEDURE

Application and admission procedure for enrolment in the first year of bachelor (higher education and university) degree programmes and single-cycle master degree programmes is run at the Higher Education Application and Information Service of the University of Ljubljana (Visokošolska prijavno-informacijska služba Univerze v Ljubljani)

7. Year Plus

During their first year at the University of Ljubljana, international students may attend the socalled Year Plus, in which the Slovenian language courses are mandatory. Year Plus is designed to help international students to adapt to the Slovenian system and culture in their first year of study in Slovenia.

Please note:

To be eligible for Year Plus, a student must be enrolled in one of the degree programmes at the University of Ljubljana.

Target group of Year Plus

International students in their first study year at the University of Ljubljana bachelor or master degree programmes with no or limited knowledge of the Slovenian language.

Please note:

Doctoral students are invited to enrol in Year Plus courses, but they cannot apply ECTS credit points from those courses towards the doctoral degree.

Recognition of Year Plus ECTS credit points

The Year Plus consists of elective subjects, offered for the individual academic year, of which at least 6 ECTS credit points are represented by the Slovenian language courses.

Student who accumulates at least 30 ECTS credit points during the first study year at the University of Ljubljana, of which at least 6 ECTS credit points are from the Slovenian language course, is entitled to a one year extension of the student status during his or her studies.

Year Plus is not designed for candidates applying for studies that require the knowledge of Slovenian at B2 level of the Common European Framework of Reference for Languages (CEFR).

8. Scholarships

Scholarships for Slovenians abroad are granted by the Public Scholarship, Development, Disability and Maintenance Fund of the Republic of Slovenia. Scholarships are granted for study at accredited public education institution at an accredited degree programme in the Republic of Slovenia. The Fund publishes open calls for applications defining the requirements for granting scholarships and the amounts of grants.

Zois scholarships are available for international students with evidence of a status as stipulated by the Slovenian legislation (EU citizenship with at least 5-year preliminary residence, an EU migrant worker or an EU frontier worker in the Republic of Slovenia or a family member of that person, or a long-term resident). The Fund publishes an open call defining all requirements, procedures and the amount of scholarship grants.

Every year, the Fund also publishes the number of available scholarships for international students other than students from the previous paragraph. The Fund publishes the calls on its website.

9. Fees

Fee is paid by:

- students of non-EU countries, excluding persons granted international protection, applicants for international protection and persons from countries with which the Republic of Slovenia has concluded bilateral agreement (Slovenia has concluded bilateral agreements with Macedonia, Bosnia and Herzegovina, Serbia, Montenegro and Kosovo);
- all students with already acquired equivalent degree of education;
- all doctoral students;
- all part-time students.

The price list is published at **www.uni-lj.si/study**. Administrative costs and compulsory health insurance are not included in the fee. These needs to be taken care of before the start of the studies.



10. Exchange students

Students of other universities, holding agreement with the University of Ljubljana may apply to become exchange students for one or two semesters. Student should contact the Office of International Relations (**intern.office@uni-lj.si**) to request the application information, which is also available on this website: **www.uni-lj.si/study/exchange**.

12. Extracurricular activities

University of Ljubljana has well organised extracurricular activities, within the scope of which individuals may acquire further knowledge and experiences contributing to personal and professional development. Extracurricular activities approved by the University of Ljubljana Senate allow students to cumulate ECTS credit points that can be applied within 5% of external electives in bachelor and master degree programmes. Furthermore, University Member (academy or faculty) may recognise informal learning extracurricular activities based on the rules laying down the procedure and criteria for the recognition of informally gained knowledge and skills.

Contentwise, extracurricular activities are clustered within the following areas:

- sports activities (over 60 sports programmes/courses);
- art and culture;
- volunteering and charity work;
- social activities;
- health and environment protection;
- · research, science and projects outside the scope of degree programmes.

- member of the European Union since 2004.

- architectural image of the city was decisively characterised by the world renowned architect Jože Plečnik;
- Kongresni trg is one of the central squares in Ljubljana and is home to the seat of the University of Ljubljana, the oldest and largest higher education and scientific research institution in Slovenia, founded in 1919.

Ljubljana is a pleasant city to live in. Although it is not among Europe's largest cities, it has everything one finds in other capitals: museums and galleries, one of the oldest philharmonic orchestras in the world, other orchestras, many theatres, a university, institutes and libraries.

The city's increasingly vibrant commercial and trading life and the rapid increase in foreign diplomatic representatives are giving it an ever greater cosmopolitan touch. It offers a wide variety of cafes, pubs, bars and restaurants. Relief from the hustle and bustle of life in the capital can be found in the numerous parks and woodland areas, which in some places reach nearly into the city centre.

14.3. TEMPORARY RESIDENCE PERMIT

Entry and residence of EU citizens

Valid personal identity document (passport or personal identity card) is sufficient to enter the Republic of Slovenia.

Entrants may stay in the territory of the Republic of Slovenia for up to 90 days of their entry in the country, however they are obliged to report the temporary address to the Police or relevant administrative unit (for Ljubljana: Tobačna ulica 5, 1000 Ljubljana, Slovenia).

In the event of exceeding 90 days, residence permit is obligatory. This can be obtained from the administrative office within the residential district (in Ljubljana: Administrative Unit Ljubljana, Administrative Internal Affairs, Department for Foreign Citizens (Upravna enota Ljubljana, Sektor za upravne notranje zadeve, Oddelek za tujce), Tobačna ulica 5, 1000 Ljubljana, every day during office hours:

Mondays, Tuesdays and Thursdays 8 a.m. - 6 p.m., Wednesdays 8 a.m. - 7 p.m., and Fridays 8 a.m. - 2 p.m.

The temporary residence permit will be issued in accordance to the conditions set by the European Union. In order to issue a residence permit to a citizen from a member state for the purpose of study the following conditions have to be met:

- valid identity card or a valid passport;evidence of admission to study;

- evidence of appropriate health insurance;
 evidence of sufficient funds for subsistence. Signed statement suffices as proof of sufficient funds for subsistence;
- personal photo (35 x 45mm).

Copy of the student's passport or identity card must be certified by a notary or at the registry of the Department for Foreign Citizens.

According to the stated directive the residence permit is granted for the period of studies or at the most for one year and can be extended in the event that the studies last for over a year.

Entry and residence for citizens of non-EU countries

The first temporary residence permit for non-EU citizens may be issued after entry into Slovenia under certain **conditions** stipulated by law to the following foreigners:

- researchers, college/university teachers or college/university associates who have concluded a hosting agreement and are lawfully residing in Slovenia on the basis of a validpassport or identity card (where no visa is required), C visa or a valid residence permitissued in another EU member state;
- international students who are lawfully residing in Slovenia on the basis of a valid passport or identity card (where no visa is required), C visa or a valid residence permit issued for study purposes in another EU member state, or D visa issued for study purposes in another EU member state.

Within the 90 day period or after the expiration of Visa D, they are obliged to apply for a first residence permit at the relevant administrative unit in Slovenia (in Ljubljana: **Administrative Unit Ljubljana, Administrative Internal Affairs, Department for Foreign Citizens** (Upravna enota Ljubljana, Sektor za upravne notranje zadeve, Oddelek za tujce), Tobačna ulica 5, 1000 Ljubljana, every day during office hours: Mondays, Tuesdays and Thursdays 8 a.m. - 6 p.m., Wednesdays 8 a.m. - 7 p.m., and Fridays 8 a.m. - 2 p.m.

The non-EU citizens who have a **valid residence permit** issued by **another state that is party to the Schengen Agreement**, may enter the Republic of Slovenia on the basis of this permit and a valid travel document and stay there for no longer than three months in a six-month period, which includes the combined duration of their stay in all Schengen States except for the state which issued the visa, starting on the date of the first entry into one of Schengen States or until the expiry of visa validity if this is shorter. Within 90 days period, they are oblidged to apply for first residence permit at the relevant administrative unit in Slovenia (in Ljubljana: Tobačna ulica 5, 1000 Ljubljana).

For first residence permit application they are required to possess the following:

- personal photo sized 35 x 45mm showing the real image of the applicant that is made in colour and fit for biometric documents;
- two fingerprints;
- evidence of admission to study, education, specialisation or professional training in the relevant educational establishments in the Republic of Slovenia;
- evidence of appropriate health insurance in the Republic of Slovenia;
- evidence of ensured funds for subsistence (sufficient proof of the fulfilment of the requirement for sufficient funds for subsistence (in the minimum monthly amount of the basic minimum income in the Republic of Slovenia) is a written statement made by the student's parents or legal guardian indicating that they would provide means for the student's subsistence. A foreign citizen may prove the fulfilment of the requirement for sufficient funds for subsistence in any other way, and the evidence will be assessed in a declaratory procedure);
- valid passport with validity extending beyond the planned period of residence in the Republic of Slovenia by at least 3 months (a copy is certified by a notary, administrative unit or the registry of the local department – the copy and valid passport is enclosed for inspection);
- police clearance certificate not older than three months issued by the home country (if the country in question issues it), translated into Slovenian, and verified.

Slovenians with no Slovenian citizenship receiving a scholarship by the Republic of Slovenia (Public Scholarship, Development, Disability and Maintenance Fund of the Republic of Slovenia) may apply for a room at the Student resident halls. The Regulations on fees and accommodation in students' dormitories for Slovene nationals without Slovene citizenship and foreigners in the Republic of Slovenia provide that up to 250 places are to be offered in Student resident halls for the recipients of ministry scholarship. Available places for the residence of scholarship recipients are assigned by the Ministry of Education, Science and Sport in cooperation with scholarship providers. Recipients of ministry scholarships are charged a subsidised rent. The Ministry or scholarship provider pays the rent directly to the student dorm, i.e. from the scholarship amount granted. All rooms are double-bedded with a common bathroom and kitchen.

14.5. HEALTH INSURANCE

International students coming from EU and EEA Member countries and Switzerland have free access to emergency or necessary healthcare services during their temporary residence in the Republic of Slovenia upon submission of evidence of their status: the European Health Insurance Card (EHIC) or a certificate as a substitute for EHIC that is issued by the competent state. This means that the doctor has to provide necessary healthcare services to students who hold a European health insurance card so that they do not have to return to their home country for medical care before the end of their intended stav in Slovenia. Students can access the services directly from health care service providers who have a contract with the Health Insurance Institute Slovenia. During their stay in Slovenia, students with valid health insurance in Australia can assert only urgent medical care with health care providers, which wave a signed agreement with the Health Insurance Institute Slovenia. They must present their MEDICARE Australian card and passport used to check the identity of the insured person from Australia.

International students from countries with which the Republic of Slovenia has concluded a bilateral agreement on social insurance have free access only to emergency healthcare services in the Republic of Slovenia upon submission of evidence of their status. The Republic of Slovenia has concluded bilateral Social Insurance Agreements with the Republic of Macedonia, Republic of Bosnia and Herzegovina, Republic of Serbia, and Montenegro. As a rule, a foreign insured person must submit sample form RM/SI 3, BIH/ SI 3, SRB/SI 03 or MNE/SI 03 to the regional unit of the Health Insurance Institute Slovenia. The Health Insurance Institute Slovenia issues a certificate which allows students access to emergency medical services from healthcare service providers who have a contract with the Health Insurance Institute Slovenia.

Exceptionally, i.e. in cases of major emergency, a foreign insured person may exercise their right to healthcare services with one of the above mentioned forms directly at the doctor's office and medical institutions.

Persons from **non-EU and non-EEA countries**, Switzerland or from countries with which Slovenia has not concluded bilateral agreements on social insurance can take out their compulsory health insurance policy at one of the local units of the Health Insurance Institute Slovenia. Upon registering for this compulsory health insurance policy, students have to submit a certificate that confirms they are enrolled in an educational programme in Slovenia. The registration and the payment of the policy's cost are the responsibility of the student.

Notably, based on their inclusion in the insurance system of Slovenia, international students have free access to health care services within the scope of compulsory health insurance. Considering that they are required to cover the difference to the full price of healthcare services themselves, it is recommended that they also take out supplementary health insurance at a commercial insurance company (Vzajemna: www.vzajemna.si, Adriatic Slovenica: www.adriatic-slovenica.si, Triglav: www.triglav.si).

14.6. STUDENT IDENTITY CARD

Student identity card is evidence of student status. Students use the identity card to exercise their rights and to obtain other benefits deriving from the student status (subsidised student meals, discounts on entrance fees to museums and other visits, etc.). Students receive their identity cards at the relevant University Member (academy or faculty).

14.7. PERSONAL REGISTRATION NUMBER (EMŠO)

The Personal Registration Number (EMŠO) is a personal identification number in the Republic of Slovenia. International students are assigned the personal EMŠO at the relevant University Member (academy / faculty).

International students may open a bank account in almost any bank in the Republic of Slovenia.

International students having a residence permit may open a resident bank account; others may open a non-resident bank account (SKB, NLB, Gorenjska Banka, Addiko bank, UniCredit Bank, Hranilnica Lon, Poštna banka Slovenije, Abanka, Banka Koper, etc.).

Most shops, hotels and restaurants accept Eurocard, VISA, Mastercard, Diners Club, American Express and other payment cards.

14.10. STUDENT WORK OPPORTUNITIES

International students studying in Slovenia and having a student status may work via student job centres or, rather, a job referral note under the same terms as Slovenian citizens.

The options and terms of student work are the same for students who are EU citizens and third-country citizens. The only difference may lie in the taxation of citizens of different countries, as it depends on a particular international agreement concluded between Slovenia and the relevant country.

Students, citizens of EEA or third-countries can work as students, providing they have a registered place of residence in Slovenia.

To work during study, student must be a member of a particular student job service. To apply, you will need:

- 1. personal identity document;
- 2. evidence of student status;
- 3. Personal registration number (EMŠO);
- 4. Slovenian tax identification number;
- 5. Slovenian personal transaction account number;
- 6. signed statement of (non-)residence.

Subsidised student meals are available in various restaurants and pubs.
